



## Bousquet Holstein's 17th Annual High School Photography Contest

Bousquet Holstein PLLC would like to cordially invite you to submit entries to our annual High School Scholarship Photography Contest, open to students in Onondaga and Tompkins Counties!

### About Our Contest

For the past 17 years, our law firm has hosted this photography contest as part of our ongoing efforts to support education and the arts in our community. Some past winners and finalists of the contest have gone on to study photography in college, and some have made photography a career after graduation.

Students from all over Onondaga and Tompkins Counties submit their photographs in accordance with our **annual theme** (see *below*). After the photos are collected, a panel of artists, photographers, and Bousquet Holstein attorneys will review the photographs and select 20 finalists. Our finalists, their teachers, and their families will be invited to an exclusive reception at the Everson Museum of Art in Syracuse, where we will display their photographs and announce our winners! This event will take place on November 5, 2025. Please note that if a finalist is unable to attend our reception, they will still receive their award.

**Awards:** Our first-place winner will receive a \$500 scholarship, and their photograph will be the featured cover of the firm's annual Thanksgiving card – sent to over 8,000 of the firm's clients and friends. Since we love and appreciate our teachers and all they do for our students, the first-place winner's art/photography class will also receive a gift of \$500 to use for future classes.

Our second-place winner will receive a \$300 scholarship, and our third-place winner will receive a \$200 scholarship.

### Theme

Each year, the theme of our annual photography contest is created in partnership with the Everson Museum of Art in Syracuse. This year's theme is titled "**Activated Communities: The Pulse of Our Spaces.**"

Our public spaces are brought to life by the people who use them. When people interact with these areas, they redefine their purpose, turning the ordinary into something vibrant and unique. These spaces hold stories, movement, and connection. This year's theme explores how our public spaces are activated in unexpected ways and captures the pulse of the communities that bring them to life. Students are encouraged to capture these moments through photography, highlighting the interaction between people and the spaces they shape.

This year's theme is inspired by the long-standing skateboarding culture at the Everson Museum's Community Plaza. Just like skateboarders have redefined that space, we encourage students to find and document places in their community that are activated in unique ways.

### How to Enter

In an effort to make our contest more accessible to students, we are offering two ways to submit photos this year.

**Submit via Google Form:** To enter our 2025 contest, students will need to fill out a **Google Form** where they will be able to upload their images directly, using either a computer or cell phone. Students will be required to login to their school-assigned google account before filling out the form. The form will allow students to submit



up to seven images. Students will be asked to get the name(s) and contact information for their subjects and a signed subject release form if needed. Here is the link to the Google Form: <https://bit.ly/BHPhotocontest>

**Submit via ShareFile:** If a student does not currently have a Google account through their school or does not want to submit their photos via Google, they can submit their photographs and entry forms using ShareFile. Please make sure the file names of the images and documents include the name of school, student's last name and image title (abbreviate if possible). If you need assistance with submissions, please reach out to us or ask a teacher for help.

**Eligibility:** Onondaga County and Tompkins County High School Students, *currently* enrolled in grades 9-12. Students may use their cell phones to take photos and do *not* need to be in a photography/art class to enter. Students who cannot attend the finalist reception in the fall are still encouraged to participate.

**Judging:** Entries will be judged on composition, imagination, relevance to theme, and creativity of content.

**Deadline:** All entries must be uploaded and received by **October 10, 2025, at 5 PM**. We will confirm receipt via email.

By entering this contest, student photographers approve and authorize Bousquet Holstein PLLC to publish, print, display, and distribute photographs in Bousquet Holstein printed publications, photo contest materials, social media, internal office galleries, and the firm's website.
